Sociology I/II
Grades 10-12

COURSE DESCRIPTION

Sociology is about people – how they act, interact, and react with others. This course is designed to help students better understand their place in the groups to which they belong and the function, influence and interaction of groups that form institutions, neighborhoods, and societies. Sociology I investigates human society, social relations, organization and change. Emphasis is placed on the study of such issues as delinquency, poverty and changing family patterns. Sociology II expands on the knowledge skills, values and social participation components acquired in Sociology I. Emphasis is placed on the study of contemporary social problems like stereotypes, crime, poverty, gerontology and mass media. Students use surveys, case studies, experiments and interviews.

Sociology I/II is a one-year elective and carries one unit of credit.
